Dear Parents/Carers,

Re: Design Museum Trip - Thursday 8th February 2024

The school has arranged a trip, for selected students that attend the Sustainability Textiles Club, to visit the Rebel : 30 Years of London Fashion Exhibition at The Design Museum, 224-238 Kensington High Street, London W8 6AG on Thursday 8th February 2024.

The venue website describes the exhibition as follows :

“Sponsored by Alexander McQueen. How does London repeatedly set the creative agenda? Find out in this major exhibition celebrating the city's leading role in global fashion. In collaboration with the British Fashion Council, it celebrates the 30th anniversary of the BFC's NEWGEN programme.”

Students should meet outside Inglewood at 8.40am where they will be registered. They will then walk to Chislehurst Station to catch the train to Cannon Street and then a tube to High Street Kensington. Students will be dismissed at around 3.00-3.30pm from Chislehurst Station after the trip in order to make their way home.

Students should wear normal school uniform, but should wear comfortable shoes. Students should also bring a packed lunch and/or money to buy refreshments. They will also have an opportunity to visit the gift shop at the museum (a suggested maximum of £10 to spend).

An application has been submitted for free train travel for the trip, however if unsuccessful **students may need an Oyster card or money to purchase a ticket to travel on the day** (this will be confirmed prior to the trip). There are no other costs for this trip.

If your child would like to attend the trip please consent via Gateway (under Payments) by Friday 26th January 2024. Please note - your consent includes dismissal from Chislehurst Station at the end of the trip. If you would prefer your daughter to walk back to school after the trip with a member of staff please email SMcaleer@bwsgirls.org to make that request.
