## **Re: Year 7 - End of Year Trip - Friday 12<sup>th</sup> July 2024 Venue Change – Chessington World of Adventures**

Following our previous letter we can now confirm that the Year 7 end of year trip will now be to Chessington World of Adventures on Friday 12<sup>th</sup> July 2024. (This is a change of venue and the trip will no longer be to Grippid in Hounslow).

Students should arrive at school at the earlier time of 8am will be travelling by coach and will return to school at approx. 4.00 - 4.15pm. Students should wear sensible clothing and footwear for an active day outdoors. Students should bring a packed lunch and drinks, or means to purchase. Please be aware that the outlets at the venue may be card payment only.

The cost of the trip is **£42.50** which covers the venue ticket and coach travel costs. The first instalment of **£22.00** to secure a place on the trip should be made via School Gateway by **Friday 12<sup>th</sup> April 2024**. If the first payment has already been made in respect of the Year 7 end of year trip then this payment will now not be available on Gateway and a place will have been allocated on the new trip.

**Please note this is a very strict deadline and no late comers will be added past this date as bookings will be confirmed with the suppliers.**

If you made the first payment for the Grippid trip and your child does not wish to attend the trip to Chessington please email [SJohnson@bwsgirls.org](mailto:SJohnson@bwsgirls.org) for assistance.

The second payment of **£20.50** will then be due by the end of May 2024. Please note that if a place is secured on the trip by making the first payment the second payment will then be due/payable.

If your child has a music lesson on the day of the visit they should notify their peripatetic teacher in advance. We also request that students do not bring valuable articles with them. Staff cannot be held responsible for any loss of personal belongings.

Parents/Carers are advised that this may incur cancellation charges.

Parental consent for a trip acknowledges the responsibility of the parent to ensure their child has been made aware of the contents of the Bullers Wood MAT Code of Conduct for Students on school trips, available on the school website. If a student's conduct on the trip would have led to a fixed term exclusion from school, parents are expected to collect their daughter/son from the trip destination. Parents would be liable for all associated costs relating to the collection of the student.

Payment signifies the commitment by the payer to the students' participation in the trip/activity and confirms parental consent. The cost of the visit/activity is non-refundable except in the case of serious illness, when a doctor's certificate will be required. Payments are used to secure firm bookings with the companies whose services are engaged for the visit. Please ensure all payments are made on-line as described by the due date.
