Dear Parents and Carers

Re: Year 8 - Trip to see “Wonka” at The Vue Bromley – Monday 18th December 2023

A visit has been arranged for Year 8 students to see an exclusive screening of “Wonka” at The Vue Bromley on **Monday 18th December 2023** as a celebration of the excellent start students have made to their studies in Year 8.

The cost of the visit is **£5.50** per student, this should be paid via School Gateway by **Thursday 30th November 2023**. **Please note that this is a strict deadline in order for tickets to be purchased and no students can be added after this date.** Any students not wishing to attend the trip should attend school as usual and arrive at normal time.

If your child receives Pupil Premium funding then the cost of this trip will be covered by the school, however you must log onto School Gateway to give your consent for them to attend.

Students should wear school uniform and **meet staff outside the main entrance to the cinema** (by Pizza Express) at 8.35am where they will be registered. The screening will start at 9.00am. Students will then walk back to school with staff.

We would also ask you to impress upon your child the importance of correct behaviour both outside the cinema and during the showing. Students can bring money to purchase refreshments prior to the showing (we would suggest a maximum of £10) or they can bring snacks/drinks with them (please ensure no snacks contain nuts).

Students must ensure that their mobile phones are turned off whilst in the cinema and shown remain switched off until the end of the school day. Please note that staff will not be responsible for any loss of personal belongings.

If your child has a music lesson on the day of the visit they should notify their peripatetic teacher in advance.

We are looking forward to the visit and are sure that the year group will have both an enjoyable and memorable trip.
